### Rental conditions:

The rental fee includes extra charges, such as freight- and packing costs as well as legal VAT. Only the return postage has to be paid by you. Immediate dispatch after receipt of the money transfer. The rental period starts with the delivery to the customer (invoice date) and ends after a rental period of 30, 60 or 90 days. The rental can be extended by a further 30 days each time.

The customer is obliged to return the C-IR-System after the rental period in faultless condition, in its original packaging, undamaged and cleaned to VON BISMARCK TRADING.

Systems damaged by you will be replaced by VON BISMARCK TRADING and the costs will be invoiced to the hirer.

Should the system not be returned in time (the date stamp of the dispatch note counts) a flat rate of € 15.00 per day, plus VAT will be invoiced by VON BISMARCK TRADING. The total amount will automatically be deducted from the deposit paid. Please note that with the rental no right to return or conversion is granted to the hirer.

Until the products have been paid in full the right of ownership remains with VON BISMARCK TRADING.

### Conversion from a rental to a purchase:

If the hirer wishes to purchase the C-IR-System after the rental period, the rental paid will be fully deducted from the purchase price. The customer will receive a new replacement CIR-system if he has received a used CIR-system for hire. If he has received a new and unused CIR-system for hire he will keep the supplied system when converting to a purchase agreement.
